6. - 15.2 We are the promoter of the Competition. Any reference to **we/us/our** includes our directors, sponsors, agents or consultants, where the context allows for it.
- 15.3 These Terms are governed by the Consumer Protection Act 68 of 2008.
- 15.4 These Terms apply to the Competition and all information relating to the Competition (including any promotional or advertising material that is published).
- 15.5 By entering the Competition, you are bound by these Terms and if applicable, the terms of the Prize and the Standard Bank product terms and conditions that relate to the Competition or the Prize.
- 15.6 If the Prize involves any goods or services provided by a third party, the Prize will be subject to the third party's terms and conditions.
